Keren Shiloh L'Yaldei Israel is a registered tax-exempt nonprofit Israeli charitable organization which received grants of \$400,000 from Shiloh Israel Children's Fund in 2024.

Grants in the amount of \$400,000 to Keren Shiloh L'Yaldei Israel (a registered Israeli non-profit organization) which has the same primary exempt purpose as Shiloh Israel Children's Fund, Inc., were used to help with expenses and improvements to the Therapy Center, support groups for children with learning challenges, parenting workshops to help parents cope with the difficulties of raising children in Israel's heartland, psychotherapy, supplemental education and camps for children traumatized by terror.

After the October 7th, 2023 massacre, when 1,200 Israelis were brutally murdered, tortured, raped, and beheaded by Gazan Arab terrorists and civilians, SICF expanded its services, including a new mobile therapy program for the enormous number of evacuees and other serious terror victims. The expanded programs continued through 2024. The organization is struggling to meet the needs of the overwhelming number of terror victims and evacuees who have sustained severe trauma.
